### Directions to Anthony's Lake Club

From all points south, take Route 7 to Route I-84 eastbound to Exit 4. Turn right at the end of the ramp onto Mill Plain Road. Turn left at the fourth light (7-11 will be on right). Take the first right after the I-84 overpass onto Christopher Columbus Avenue. Turn left onto Vespucci Drive and go 350 feet to Anthony's Lake Club. From points east, get off I-84 westbound at Exit 4 and follow directions above. From points west, get off I-84 eastbound at Exit 2, turn left on Milestone Road, proceed under the underpass and take a right onto Mill Plain Road (Route 202E). Proceed 1.4 miles on Mill Plain Road until you come to Kenosia Ave (opposite 7-11 on your left). Proceed on Kenosia Ave. as above.
